5304	Laser Federal 941 Payment Voucher
2598-2	1098 Mortgage Interest Carbonless Electronic Filing Mailer–Dateless *Suggest using # 2098-2, same construction/layout-however this is a <u>“Dated Format”</u>
2639-4	1099 “R” Alternate 3-Up Carbon Electronic Filing Mailer–Dateless *Suggest using # 7149-4. This form is the standard 2-Up format with Postal Indicia capabilities. Form has the same distribution, however significantly different print layout. Will Require Reprogramming.
2690-2	1099 Interest Multiple Account Carbon Electronic Filing Mailer–Dateless *May be able to use # 2176-2, Significant differences with Box 4 Federal Income Tax Withheld, Call for Samples, Will Require Reprogramming
6095-4	1099 “H” 4 part 1-wide Carbonless *Suggest using Laser Cut Sheet Format, Items # 5101 Federal Copy A, # 5102 Recipient Copy B, and # 5103 Payer and/or State Copy C. Same format on laser cut sheets. To get 4 parts, order twice as many of item # 5103 as you did of # 5101 and 5102. Call for samples.
9420-3	941B Supplemental Record of Federal Tax Liability 3 part 1-wide Carbonless *Suggest using Laser Cut Sheet Format, Item # 5305. Same format on laser cut sheets. If 3 parts/copies are needed, order 3 times the quantity you would have ordered of the continuous forms.
